241 CONFIRMATION OF MINUTES

The Minutes of the meeting held on 6th and 20th January 2011 were confirmed and signed by the Chairman.

242 POLICE REPORT

Crime statistics were received, circulated and discussed. PCSO Noble referred to the Police Authority's policy of rotating PCSO and introduced PCSO 2863 Jason Knowles who would be working in Gresford from time to time as replacement for PCSO Noble.

245 TEMPS OUT OF SCHOOL CLUB, MARFORD

(Councillors J L Jones declared personal non pecuniary interest in this matter and left the room took no further part in the discussion or voting thereon)

Councillor R H Willis was appointed Presiding Chairman for this item

Representatives of the Club were present and up dated the Council on the efforts they were making to meet the Council's requirements for the loan. They answered the many questions of the members.

In order that there would be no delay on the council's part when the club was ready to receive the cheque, the Council agreed to have an item on the agenda each month to consider making the loan of £50,000 to the Club.

Councillor Jones resumed chairmanship of the meeting.

Allington Park and Marford Play Areas

It was noted that the meeting with the Council's preferred contractor would take place on Thursday 24th February at 5.00 pm at Gresford Memorial Hall.

Reinstatement of Footpath, boundary fence and gate at Woodlands Road

A reply was received from the Chief Executive. Members expressed their disappointment at the tone of the reply.

Accordingly, the Council resolved to seek the help of the Leader of Wrexham Council to resolve this intolerable situation. The Clerk of the Council was instructed to make the representations.

Zebra Crossing, Chester Road, Marford

A reply was received from Network Policy & Road Safety Manager of Wrexham Council.

It was resolved to seek a meeting on site with the appropriate Officers of Wrexham Council and the police with a view to installing an acceptable form of hazard warning signs at the on the approaches to the zebra crossing.

Cycle Parking Facilities

A reply was received and noted from Network Policy & Road Safety Manager of Wrexham Council.

Youth Councils

This matter had now been discussed by the Wrexham Town and Community Councils Forum and would be raised with One Voice Wales.

Oak Tree at the Junction of Chester Road and Clapper Lane

The meeting with the Area manager of Wales and the West Utuility Services was to be held on site on Wednesday, 9th February at 11.00 am.

BT Red Kiosk Adoption Scheme

Any transaction with BT to purchase one of these red kiosks contained an agreement that if the purchaser proposed to sell the kiosk to a third party the kiosk must be offered back to BT in the first instance. The position was noted.
