## **257 GRESFORD TRUST**

- Support and actively lobby on behalf of the Trust

- Support the running of the Trust by providing regular revenue funding to appoint a Caretaker for 20 hours per week form the sum of £9,000 p.a.

That publicity and information should be given to all interested parties in order that the children were aware of the works and that the play areas would be closed during the respective periods were work was carried out That the Play Areas Sub-Committee should supervise and agree the work and

any ancillary issues

# Oak Tree at the Junction of Chester Road and Clapper Lane

A further meeting had been held with the Engineer of Wales and West Utilities. The tree should removed from the land adjoining the Old Wrexham Road to coincide with the planting season and to this end the Engineer would see if the Company's equipment was sufficient for lifting and transporting the heavy tree.

It was agreed that further enquiries be made with Mr Simon O'Rourke, Woodcarver from Rossett to see if he would undertake the work at its present location or whether the tree should be removed to The Cross. It was also agreed to make enquiries with Glyndwr University to see if their Arts College students could prepare a suitable design. It was be necessary to seek the observations of the Highway Authority.

P/2011/0094 – Erection of 1 No. non-illuminated flag sign ATS Euromaster, Marford Hill, Marford – *The Council considered that this type and size of sign was inappropriate in* 

the Conservation Area and that a more standard house sign would be more in keeping with the area.

P/2011/0099 – Erection dwelling (previously granted under Code No P/2005/1380), land adjacent to Quarry Rigg, Pant Lane, Gresford – *The Community Council considered that the proposed dwelling should not be out of line with the adjoining properties in terms of frontage and height.*
