269 PRESIDING CHAIRMAN

270 CONFIRMATION OF MINUTES

The Minutes of the meeting held on 13th May 2010 were confirmed and signed by the Presiding Chairman.

271 POLICE REPORT

A written report was received, circulated and discussed together with other matters of concern. It was also noted that Wrexham County Borough Council was reviewing their contribution to the provision of police community support Officers.

272 PUBLIC PARTICIPATION

No members of the public were present.

273 ITEMS FROM PREVIOUS MEETINGS:

Allington Park and Marford Play Areas

Councillor J Dutton reported on the consultations with the two schools, that a questionnaire had been prepared to elicit responses to the proposals received from the two companies for both playgrounds. Ms Lis Thompson was carrying out analysis of the different schemes. The Clerk of the Council reported that the Welsh Assembly Government was prepared to accept applications for loan consent a time when the Community Council was confident that the proposals would proceed and a business plan would be required.

The Council noted the present position.

Tidy Towns Grant Requests 2010 - 2011

A letter was received from the Chief Environment Officer indicated that the Community Council's request would receive £3,000 direct funding from the grant, however additional resources both Council and voluntary sector could be used to enhance the schemes.

It was reported that a quotation for watering the tubs and beds the year had been obtained at an estimated cost of £450.00 and the plants had been ordered.

The local Manager for Wales and the West Utilities had indicated that they were prepared to consider and invoice for the recently planted oak tree at The Cross which had failed as a result of the numerous gas leaks in the area in which it had been planted.

The Council resolved to proceed with the Tidy Towns proposals for 2010 – 2011 with the help of the local voluntary supporters of IMAGE, Gresford & Marford Scouts and guides and the two local schools.

It was noted that UHY Hacker Young had fixed 31st July 2010 for the annual external audit of the Council's accounts. A Summary of the Accounts for the year was received.
